

PHOTOGRAPHY SERVICES AGREEMENT

This agreement is between *Ilva Rimicane* and

Date of wedding with the beginning of service at Selected wedding package:
..... for an amount ofGBP.

The wedding package includes:

- All day photography coverage;
- 600-900 fully edited images;
- transport costs to and from the venue;
- Images delivered via an online gallery (Shootproof.com);
- A USB drive.

1. This agreement contains the entire understanding between *Ilva Rimicane* and the Client. It supersedes all prior and simultaneous agreements between the parties. Only those changes or modifications specifically placed in writing, attached, dated and signed by the Clients and *Ilva Rimicane* at the time of acceptance of this contract shall be recognised as amendments to this contract.

2. Upon receipt of deposit, *Ilva Rimicane* will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation deposit of 250 GBP of the package price is non-refundable, even if the date is changed or the wedding cancelled for any reason; including acts of God, fire, strike and/or extreme weather. The Reservation Deposit is to be paid within seven (7) days of signing the contract. The Reservation Deposit is applied towards the contracted wedding photography package.

3. In the event that the Client cancels the contracted services for wedding photography outlined in this contract before the wedding ceremony takes place, the deposit will be forfeit. *Ilva Rimicane* agrees to refund all additional paid money (less expenditures for which receipts will be provided), to the client.

4. The Client understands and agrees that the entire amount owed for the wedding photography package is due seven (7) days after the date of the wedding.

5. In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. *Ilva Rimicane* will make every effort to secure a replacement photographer of the same professional standing and ability able and/or willing to provide a similar package as chosen in this contract at the same/similar tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received.

6. *Ilva Rimicane* takes the utmost care with respect to exposure, transportation and processing of photographs. However, in the unlikely event of the Client's photographs being lost, stolen or destroyed for reasons within or beyond *Ilva Rimicane's* control, the latter's liability is limited to the return of all payments received for the event package, together with restaging photographs of the couple at a later date.

7. The Photographer will document the events in a candid manner and take formal portraits as necessary.

8. Prior to or during the event, the Client may inform the photographer of subjects which they would like photographed, but the final content of the images is at the discretion of the Photographer.

9. Although every possible care will be taken to produce photographs of all important and special events during the wedding, *Ilva Rimicane* cannot place an unconditional guarantee on the above.

10. The Client will receive an edited selection of high-resolution JPG digital images. The entire copyright in the photographs is retained by the photographer at all times throughout the world. The client must seek permission for use beyond reproduction and printing for friends, guests and family.

11. The Clients hereby allow the photographer to display any images covered by this contract and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles, and other such media, providing that the images are used lawfully and without damage to the clients.

12. The Client understands that photographs will be delivered via an online gallery within 6 weeks after the wedding.

13. If the additional products ordered directly from the photographer, such as prints, albums, USB drives etc. are damaged during shipment, Client has right to request a replacement copy.

14. The photographer is limited by the guidelines of the ceremony official or the reception site management. The Client agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is The Client's responsibility; *Ilva Rimicane* will offer technical recommendations only.

15. *Ilva Rimicane* reserves the right to ask other people to refrain from taking photographs at key times, if it is considered that this may compromise the quality of the photographs.

16. The Client and Photographer agree that cooperation and punctuality are essential to accomplish the goals and wishes of all parties. If the Client does not arrive at the appointed time for the event, shooting will commence at the scheduled start time and end at the scheduled end time. All additional time beyond the scheduled end time will be billed to the Client.

17. *Ilva Rimicane* is obliged to arrive a minimum of 20 minutes before the beginning of service in a clean, sensible attire and good physical condition.

18. The Client is responsible to cover *Ilva Rimicane's* transportation expenses from Edinburgh to and from the venue or provide alternative means of transportation, if the event location is to be set outside Edinburgh. Estimated costs, if applicable and not included in the package, to be agreed upon prior the wedding date.

19. This document contains two (2) pages and is created in two (2) identical copies one (1) for each party. If any provision of this agreement is held to be invalid or unenforceable under the law, the validity of this agreement as a whole shall not be affected, and the other provisions of the agreement shall remain in full force and effect. I have read and understood the terms above. I hereby agree to the terms of this agreement.
